MUS 92B ORCHESTRA WORKSHOP

Credit Hours: 1 Lab: 2

PREREQUISITE: instructor permission required

COURSE DESCRIPTION

This class offers group instruction for intermediate level string students 4th grade or above.

1. <u>COURSE GOAL</u>

Become proficient in publicly performing in an ensemble with a stringed instrument (violin, viola, cello, or string bass).

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 recognize the foundations of music theory and notation.
- 2.2 describe music history and the different styles of music.
- 2.3 play a stringed instrument.
- 2.4 participate in basic ensemble playing.
- 2.5 display productive practice habits.

3. METHODS OF INSTRUCTION

- 3.1 Teacher modeling and student demonstration
- 3.2 Application of critical thinking skills
- 3.3 Small group and large group rehearsal
- 3.4 Discussion of effective practice strategies

4. LEARNING ACTIVITIES

- 4.1 Technical warm-ups emphasizing varieties of bowing, scales, rhythms, and position work
- 4.2 Integrating appropriate bowing to a variety of music styles based on historical and geographical elements
- 4.3 Playing alone, in small groups, or with the entire orchestra demonstrating growing proficiency in their developing skills
- 4.4 Development of relative intonation
- 4.5 Improving technical skills such as vibrato, shifting, and intonation
- 4.6 Ensemble playing
- 4.7 Analyzing the music learned in class to determine appropriate interpretation of performance

5. <u>EVALUATION</u>

- 5.1 Performances
- 5.2 Performance assessment, including self assessment
- 5.3 Participation

6. STUDENT RESPONSIBILITIES
