# PEM 201 THE BUSINESS OF ATHLETIC COACHING

Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: None

### COURSE DESCRIPTION

Fundamentals of coaching theory, concepts and practices for effective sports programs.

### 1. COURSE GOAL

This course prepares learners to develop sufficient knowledge and organizational skills for athletic business and individual practice, along with the knowledge, technique and strategies to compete successfully in the business.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Explain the basic principles of management as applied to athletic programs.
- 2.2 Describe the basic tenants of human resource management as applied to athletics.
- 2.3 Identify the fundamentals of budgeting, accounting and procurement and relate them to athletic program needs.
- 2.4 Discuss legal aspects involved with athletics within a selected sport.
- 2.5 Create a master/seasonal plan for a sport including daily practice plans, conditioning program, skill requirements and progressions.
- 2.6 Demonstrate the importance of the coach-player relationship and the performance environment.
- 2.7 Identify a foundation philosophy for making coaching decisions.

## 6. STUDENT RESPONSIBILITIES
