PEM 202 SPORTS INJURY MANAGEMENT

Credit Hours: 3 Lec: 2 Lab: 1

PREREQUISITE: None

COURSE DESCRIPTION

Introduction to principles and techniques of preventing, treating and rehabilitating sports-related injuries. Includes recognition of sports injuries, therapeutic methods, mechanisms of sports injuries and taping and wrapping techniques.

This course provides the learner with information and techniques needed to understand sports injuries and rehabilitation.

6. STUDENT RESPONSIBILITIES
