ARIZONA WESTERN COLLEGE SYLLABUS

PEM 206 TEAM SPORTS OFFICIATING Credit Hours: <u>3</u> Lec <u>2</u> Lab <u>2</u>

PREREQUISITE: None

COURSE DESCRIPTION

Familiarization with and application of the rules of team sports (football, volleyball, basketball, baseball, soccer and softball) from the standpoint of an official. Includes current methods and materials to develop competency in executing official rules. Students will complete sports specific certification exams.

1. <u>COURSE GOAL</u>

This course provides learners with knowledge and techniques to understand the regulations and rules of football, volleyball, basketball, baseball, soccer, and softball; prepares students to officiate at the junior high level.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Identify the rules of each sport stated above.
- 2.2 Apply and interpret rules governing the sports.
- 2.3 Demonstrate proper use of equipment.
- 2.4 Demonstrate the correct procedures and mechanics when officiating.
- 2.5 Establish and describe their philosophy of officiating.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.

If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
