COURSE DESCRIPTION

Introduction of entry-level athletic training skills within the daily operations of the athletic training room and in the care of athletes.

1. <u>COURSE GOAL</u>

Engage in practical and clinical learning environment designed to prepare students for an accredited athletic training education program.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Utilize first responder skills.
- 2.2 Provide treatment to student-athletes under the direction of an Athletic Trainer Certified/ Licensed (ATC/L).
- 2.3 Discuss injury/condition history with student-athletes.
- 2.4 Assist in practice and event field/court setup.
- 2.5 Proficiently tape ankles, wrists, and thumbs on student-athletes.
- 2.6 Facilitate athletic training room organization and sanitation.

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
