PHI 220 MEDICAL ETHICS Credit Hours: <u>3</u> Lec <u>3</u>

General Education Course: C (Ethnic, Race, Gender Awareness)

PREREQUISITE: ENG 101 or 107

COURSE DESCRIPTION

Philosophical examination of moral problems that arise in relation to medicine and health care. Topics include end of life, reproduction, patient's rights, and justice in the distribution of health care.

1. COURSE GOALS

- 1.1 Become familiar with important ethical issues that arise in medicine and health care, utilizing major ethical theories to analyze these issues.
- 1.2 Examine assumptions, goals, principles, and actions as they affect medical practice and society as a whole.
- 1.3 Understand the philosophical models of care that inform medical practice today and become familiar with alternative models.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate understanding of the nature of ethics as a discipline.
- 2.2 identify and describe major ethical theories in the history of philosophy, applying the insights of those theories to the medicine and health care.
- 2.3 observe and judge by ethical standards his or her own experiences related to medical practice and health care.
- 2.4 formulate and defend an ethical position related to medical practice and/or allocation of health care resources.
- analyze the philosophical models of care that currently inform medical practice, describing the ethical judgments those models tend to generate.
- describe alternative philosophical models of health care along with the ethical judgments they would be likely to generate.
