PIT 109 IT Automation with Python

Credit Hours: 9 LEC 9

PREREQUISITE: NONE

COURSE DESCRIPTION

This asynchronous, beginner-level course is designed to provide IT professionals with in-demand skills, such as Python, Git, and IT automation, to advance their careers. This program consists of six modules in topics such as Python, Python interaction with operating system, Git and GitHub, troubleshooting and debugging techniques, configuration management and the cloud, and automating real-world tasks with Python.

This course is Open Entry/Open Exit (OE/OE).

1. COURSE GOAL

This program builds on your IT foundations to help you take your career to the next level. It is designed to teach you how to program with Python and how to use Python to automate common system administration tasks. You will also learn to use Git and GitHub, troubleshoot, and debug complex problems, and apply automation at scale by using configuration management and the Cloud.

Upon satisfactory completion of this course, students will be able to:

- 2.3 Understand the role of Automation in IT

- 2.7 Analyze real-world IT Problems and implement the appropriate strategies to solve those problems.
