COURSE DESCRIPTION

Fundamentals of building IT infrastructure on Amazon Web Services (AWS). Optimizing the use of AWS Cloud through the development of an understanding of AWS services, best practices, and how they fit into cloud-based solutions.

- 1.1 Introduce students to cloud concepts, AWS core services, security, architecture, pricing, and support.
- 1.2 Prepare students for AWS Certified Cloud Practitioner Certification.

- 2.10 Formulate decisions based on recommended architectural principles and best practices.
- 2.11 Evaluate AWS compute and networking options.
- 2.12 Examine alternative support options and features.
