## PLS 160 INTRODUCTION TO SOUTHWESTERN ALTERNATIVE CROPS

Credit Hours: 3 Lec 3

## **COURSE DESCRIPTION**

This course will introduce students to non-vegetable crops grown in the Desert Southwest (i.e. tree crops, alfalfa, cotton, sugar beets, small grains, dates, etc.). The history, introduction, production, and economic impact of the crops will be discussed.

## 1. COURSE GOALS

- 1.1 Identify agronomic important crops in the southwest.
- 1.2 Determine the economic importance of the alternative crops grown in the southwest.
- 1.3 Identify the history and uses of southwest alternative crops and their impact on agronomic practices.

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify commercially important non-vegetable crops to the Desert Southwest.
- 2.2 discuss the history of each crop and their introduction to the southwest.
- 2.3 evaluate production methods employed by growers to generate a successful yield.
- 2.4 identify harvesting techniques used for these crops.
- 2.5 discuss the impact of mechanical engineering on the future of harvesting methods.
- 2.6 identify marketing techniques for these crops.
- 2.7 recognize the importance of these crops on soil health.
- 2.8 identify common pests and the negative effects on the final commodity.
