COURSE DESCRIPTION

To introduce students to the world of IPM through the understanding of concepts, practices and language of the control of agromonic pests and an introduction to major pests and control measures in the Colorado River Valley.

- 1.1 Learn the required skills to handle farm chemicals.
- 1.2 Gain the necessary skills and knowledge to effectively control common agricultural pests.

- identify the safety hazards associated with handling farm chemicals.
- 2.2 identify common agricultural pests and recommend control strategies.
- 2.3 discuss federal and state laws governing pesticide use.
- 2.4 analyze environmental impacts of pesticides in soil and water.
- 2.5 identify common herbicides used in the desert southwest.
- 2.6 discuss pesticide formulation and calculate rates based on manufacturer guidelines and regulations.
- 2.7 assess the integration of new technologies pertaining to pesticide use.
- 2.8 compare biological and chemical control methods.
- 2.9 identify pesticide classes, both natural and synthetic, commonly used in agriculture.
- 2.10 explain the utilization of plant growth regulators in cropping systems.
