## PLS 240 PLANT PROPAGATION

Credit Hours: 3 Lec 3

PREREQUISITE: None

COURSE DESCRIPTION

To prepare the student with knowledge and skills in sexual and asexual propagation of crops to include genetics and breeding practices, propagation techniques, and technology.

1. COURSE GOAL

This course prepares learners to propagate plants via sexual and asexual methods in laboratory and commercial settings.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify the basic principles of sexual reproduction and its relationship with commercial seed production.
- 2.2 discuss the basic principles of crop breeding to include, self-pollination, cross-pollination, roqueing, and hybridization.
- 2.3 identify the basic principles of asexual reproduction and its relationship with commercial crop production.
- 2.4 describe the history, importance and scope of plant propagation and how plant propagation influences genetic engineering.
- 2.5 describe the processes required to grow and establish transplants commonly used in crop production.
- 2.6 analyze sexual propagation techniques used in commercial crop production- seeding geometry, seed depth, planting equipment, etc.
- 2.7 describe the processes required for grafting and budding in citrus as well as other asexual propagation methods utilized in the desert southwest; ie tomatoes or date palms.
- 2.8 identify the structure and function of flowers, roots, stems and leaves.

3. METHODS OF INSTRUCTION

- 3.1 Lectures by the professor or invited speakers
- 3.2 Audio-visual
- 3.3 Class Discussions through Blackboard

4. LEARNING ACTIVITIES

6. STUDENT RESPONSIBILITIES
