PLS 290 VEGETABLE CROP PRODUCTION

Credit Hours: 4 Lec: 3 Lab: 3

PREREQUISITE: None

NOTE: MAT 121 or higher recommended

COURSE DESCRIPTION

A practical approach to commercial vegetable production. Deals with the principles, economics, and production practices of principle vegetable crops grown in the Southwest.

COURSE GOALS

This course prepares learners

- 1.1 To grow, manage, and harvest vegetable crops
- 1.2 To identify and solve some of the problems facing production and distribution
- 1.3 To learn new and innovative production techniques
- 1.4 To define specific growth processes of each crop studied that leads to a harvestable product
- 1.5 To identify seed and plant characteristics of major vegetable crops

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify and demonstrate the basic principles of vegetable cropping systems and production
 - 2.1.1 identify land preparation techniques
 - 2.1.2 identify common cultural practices
 - 2.1.3 calculate seeding rates
 - 2.1.4 identify fertility requirements of each vegetable crop including the plant –soil relationship
 - 2.1.5 identify planting and harvest date intervals in relation to temperature and cultural practice
 - 2.1.6 identify common pests and pest control methods
 - 2.1.7 identify growth processes that lead to a marketable product at harvest
 - 2.1.8 identify methods of harvest
- 2.2 describe the history, importance and scope of the vegetable industry and the systems of plant improvement
- 2.3 identify common vegetable crop plants and seed
 - 2.3.1 identify the morphology of each vegetable crop
 - 2.3.2 identify the scientific name and common families
- 2.4 describe the world food supply, its distribution and how it relates to US production and marketing
- 2.5 identify the key components of crop production economics
 - 2.5.1 discuss crop contracts
 - 2.5.2 discuss cost of producing the crop
 - 2.5.3 discuss crop loss and the methods of avoiding complete failure
 - 2.5.4 complete harvest analysis and profit and loss statements
