POS 222 NATIONAL CONSTITUTION AND GOVERNMENT

Credit Hours: 1 Lec 1

PREREQUISITE: None

COURSE DESCRIPTION

Deals with the constitution and government of the United States; specifically designed to meet the federal constitution requirement for teacher certification in Arizona, with an intensive study of the written constitution, as well as a survey of the American governmental institutions which are based on it.

1. COURSE GOALS

- 1.1 Read, discuss and understand the provisions of the U.S. Constitution.
- 1.2 Survey the governmental and political institutions at the national level, which are based on that constitution and the political environment within which they function.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 conduct an article-by-article overview and analysis of the Constitution of the United States.
- 2.2 become familiar with the major institutions of government in the United States including executive, legislative, and judicial agencies.

3. METHODS OF INSTRUCTION

Instructional objectives will be met through the use of lectures, reading, discussion, and audio-visuals

4. LEARNING ACTIVITIES

- 4.1 Read the assigned material from the textbook on the Constitution
- 4.2 Participate in open discussion on the assigned readings and lecture material
- 4.3 Perform adequately on a final examination composed of 60 multiple-choice questions

5. EVALUATION

- 5.1 Grade will be earned by an assortment of learning activities, exams, assignments, and participation

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.

- 6.5 Texts and Notebooks: Students are required to obtain the class materials for the course.
- 6.6 Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for “No Show” reporting during the first 10 days of each semester.
- Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.
- For online classes, *student attendance in an online class is defined as the following* (FSA Handbook, 2012, 5-90):
- Submitting an academic assignment
 - Taking an exam, an interactive tutorial or computer-assisted instruction
 - Attending a study group that is assigned by the school
 - Participating in an online discussion about academic matters
 - Initiating contact with a faculty member to ask a question about the academic subject studied in the course
