# ARIZONA WESTERN COLLEGE SYLLABUS

PSY 281 ABNORMAL PSYCHOLOGY

Credit Hours: 3 Lec.: 3

PREREQUISITE: PSY 101

### **COURSE DESCRIPTION**

This course is an undergraduate level introduction to the concepts of abnormality, mental health and mental illness. It serves as an introduction to the concepts of normality and abnormality in a cultural context. It also covers current diagnostic categorizations of abnormality and treatment of mental illness along with historical perspectives on these diagnoses and treatments. It does not train students in diagnosis or intervention. Abnormal psychology examines the causes, diagnosis, assessment, treatment, and possible prevention of mental disorders; including historical and current theoretical perspectives, classification systems, cultural perspectives and ethical issues.

### 1. COURSE GOALS

- 1.1 Think critically about concept of normalcy that they encounter in everyday life.
- 1.2 Demonstrate knowledge of the fundamental theoretical perspectives, principles, concepts, vocabulary and methodology for each of the assigned topics.

# 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate knowledge of fundamental theoretical perspectives, principles, concepts, vocabulary and methodology for each of the assigned topics.
- 2.2 compare and contrast the major theoretical perspectives found in abnormal psychology.
- 2.3 critically analyze information pertaining to abnormal psychology found in film, television, radio, print, and IT sources.
- 2.4 communicate an understanding of abnormal psychology concepts in written or oral formats.
- 2.5 describe the relevance of religion, race, class, gender, age, and ethnicity to understanding differences in the prevalence of disorders and the diagnosis, prognosis, and treatment of these disorders.
- 2.6 be able to discuss the philosophical issues surrounding the concepts of normality and abnormality.
- 2.7 demonstrate knowledge of a variety of psychological disorders including mood, personality, lifestyle, learning and sexual disorders.
- 2.8 apply concepts to current social problems/concerns.
- 2.9 think critically about ethics and apply their thoughts to real life ethical dilemmas.
- 2.10 use classroom technology effectively- blackboard/internet/internet video/power point/SPSS or other technology as appropriate.
- 2.11 successfully navigate the blackboard classroom platform and classroom ancillaries.

## 3. STUDENT RESPONSIBILITIES
