RAD 115 PRINCIPLES OF RADIOGRAPHIC IMAGING 1

Credit Hours: 3 Lec 3

PREREQUISITE: RAD 100

COREQUISITE: RAD 105 and RAD 110 and RAD 120

COURSE DESCRIPTION

Introduces the student to radiographic image production and the effects that exposure variables and radiographic accessories have on the quality of the image.

1. COURSE GOAL

Prepares the student do define, recognize, and evaluate the factors that control radiation quality and quantity and to analyze the effect of exposure variables upon image quality.

Upon satisfactory completion of this course, students will be able to:

- 2.1 Discuss how x-radiation is produced, its characteristics and interaction with matter.
- 2.2 Identify major components of the radiographic tube, control panel, and accessory equipment.
- 2.3 Use critical thinking skills to solve equipment operation problems.
- 2.4 Describe the factors that impact image resolution.
