RAD 121 CLINICAL 2 MEDICAL RADIOLOGIC TECHNOLOGY

Credit Hours: 3 Clin 18

PREREQUISITE: RAD 120

COREQUISITE: RAD 106 and RAD 215

COURSE DESCRIPTION

Continued clinical practice to further develop, apply, reinforce, and integrate concepts and theories in the performance of radiologic procedures. Concepts of team practice, patient-centered clinical practice, and professional development are practiced, examined, and evaluated. Focuses on patient care and assessment and competent performances of radiologic procedures. Imaging performed under appropriate supervision of a qualified radiographer. Introduction to the interoperative environment.

1. COURSE GOAL

Prepares the student to perform radiographic examinations by working in a clinical setting under the appropriate level of supervision.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Select technical factors to produce quality diagnostic images with the lowest radiation exposure possible.
- 2.2 Integrate the use of appropriate and effective written, oral and nonverbal communication with patients, the public and members of the health care team in the clinical setting.
- 2.3 Maintain patient confidentiality standards and meet HIPAA (Health Insurance Portability and Accountability Act of 1996) requirements.
- 2.4 Provide patient-centered, clinically effective care for all patients regardless of age, gender, disability, special needs, ethnicity or culture.
- 2.5 Adapt procedures to meet age-specific, disease specific and cultural needs of patients.
- 2.6 Critique images for appropriate anatomy, image quality, and patient identifications with the supervising technologist.
- 2.7 Demonstrate competency in principles of radiation protection.
- 2.8 Continue to meet minimum radiographic exam competencies.

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
