RAD 221 CLINICAL 5 MEDICAL RADIOLOGIC TECHNOLOGY Credit Hours: <u>5</u> Clin <u>30</u>

PREREQUISITE: RAD 220 COREQUISITE: RAD 207 and RAD 217 and RAD 225

COURSE DESCRIPTION

Continued clinical practice to further develop, apply, reinforce, and integrate concepts and theories in the performance of radiologic procedures. Concepts of team practice, patient-centered clinical practice, and professional development are practiced, examined, and evaluated. Focuses on patient care and assessment and competent performance of radiologic procedures. Imaging performed under appropriate supervision of a qualified radiographer.

1. <u>COURSE GOAL</u>

Prepares the student to perform radiographic examinations by working in a clinical setting under the appropriate level of supervision.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate advanced level skills in proper positioning and radiation exposure of the skeletal system.
- 2.2 Demonstrate intermediate level skills in utilization of the fluoroscopy unit to perform upper and lower gastrointestinal exams using the appropriate contrast media while following radiation safety guidelines.
- 2.3 Demonstrate intermediate level skills in proper positioning and exposure of fluoroscopy using the C-arm in the operating room following radiation safety guidelines.
- 2.4 Select technical factors to produce quality diagnostic images with the lowest radiation exposure possible.
- 2.5 Integrate the use of appropriate and effective written, oral and nonverbal communication with patients, the public and members of the health care team in the clinical setting.
- 2.6 Maintain patient confidentiality standards and meet HIPAA (Health Insurance Portability and Accountability Act of 1996) requirements.
- 2.7 Provide patient-centered, clinically effective care for all patients regardless of age, gender, disability, special needs, ethnicity or culture.
- 2.8 Adapt procedures to meet age-specific, disease specific and cultural needs of patients.
- 2.9 Critique images for appropriate anatomy, image quality, and patient identifications with the supervising technologist.
- 2.10 Demonstrate competency in principles of radiation protection.
- 2.11 Meet the ARRT radiographic exam and patient care competency requirements to be eligible to sit for the ARRT radiology certification examination.

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Students will participate in clinical experiences that support the competency development needed to perform the radiological exams that are specified in the course

6. <u>STUDENT RESPONSIBILITIES</u>
