RDG 91 INDIVIDUALIZED READING Credit Hours: 1 – 3 Lec 1 – 3

PREREQUISITE: None

COURSE DESCRIPTION

A program individualized for each student based on reading scores.

1. <u>COURSE GOALS</u>

- 1.1 To determine student reading and learning needs through diagnostic instruments and/or reading inventories.
- 1.2 To design an individual plan of instruction and give periodic feedback for each student.
- 1.3 To work independently to improve reading, learning, and vocabulary strategies.
- 1.4 To provide students with experience in reading fiction and informational texts.
- 1.5 To acquire strategies to become lifelong learners and critical thinkers.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate learning strategies from their individualized plan of instruction.
- 2.2 determine the topic, main idea, and supporting details from selected texts.
- 2.3 demonstrate and utilize reading strategies.
- 2.4 demonstrate ability to follow directions and maintain records.
- 2.5 utilize appropriate reading materials to improve their reading.
- 2.6 demonstrate understanding of various comprehension skills.
- 2.7 use the dictionary and context clues to develop his/her vocabulary.
- 2.8 use reading strategies of prior thinking, previewing, reciting, reviewing, and note-taking when reading texts.
- 2.9 write responses to selective texts.
- 2.10 work on reading fluency and speed.

3. <u>METHODS OF INSTRUCTION</u>

- 3.1 Lectures
- 3.2 Individual and/or group interaction between student and teacher
- 3.3 Individual conferences
- 3.4 Individual assignments
- 3.5 Groups instruction
- 3.6 Computer-assisted learning
- 3.7 Outside resources

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Assignments in varied reading materials at appropriate levels
- 4.2 Participation in teacher-student conference to facilitate on –going diagnostic teaching
- 4.3 Individualized programs of study, tailored and adapted to particular students needs
- 4.4 Use of video cassette
- 4.5 Participation in Literature Studies activities
- 4.5 Participation in literature studies' activities
- 4.6 Exercises to assess comprehension of selected and assigned readings

5. <u>EVALUATION</u>

5.1 Completion of all classroom and assigned work

- 5.2 Quizzes
- 5.3 Participation in discussion
- 5.4 Assessment including pre- and post- testing, inventories and other diagnostic instruments

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
