SPA 095 BEGINNING CONVERSATIONAL SPANISH 1 Credit Hours: <u>3</u> Lec <u>3</u>

PREREQUISITE: None

COURSE DESCRIPTION

Basic communications skills with emphasis on oral communication and pronunciation. Grammar is taught only as it will facilitate conversation.

1. <u>COURSE GOALS</u>

- 1.1 Listening comprehension: Students acquire basic aural skills.
- 1.2 Speaking: Students will acquire basic oral skills.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 communicate in highly predictable everyday situations.
- 2.2 process and replicate oral information at low novice level.
- 2.3 produce limited memorized material in simple statements or questions.
- 2.4 demonstrate understandable pronunciation skills when speaking.
- 2.5 recognize and explain everyday cultural patterns.
- 2.6 present and articulate personal information.
- 2.7 act appropriately in common everyday situations.

3 METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Discussions, readings, repetition of phrases, role playing of dialogues, and oral and written drills
- 3.3 Cultural multi-media
- 3.4 Small group and class discussions
- 3.5 Any supplementary or unique method of instruction could be used by the instructor as long as the major objectives are met

4. <u>LEARNING ACTIVITIES</u>

- 4.1 Group work in the classroom
- 4.2 Oral and listening quizzes and tests
- 4.3 Cultural multi-media
- 4.4 Classroom discussions
- 4.5 Commands executed in class

5. <u>EVALUATION</u>

- 5.1 A test after each chapter and a comprehensive final are required
- 5.2 Participation
- 5.3 Homework

6. <u>STUDENT RESPONSIBILITIES</u>

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from

the course and fails to complete the requirements of the course, the student will receive a failing grade.
