Credit Hours: 3 Lec 3

PREREQUISITE: SPA 95

COURSE DESCRIPTION

A continuation of SPA 95. Basic communication skills with emphasis on oral communication. Grammar is taught only as it will facilitate conversation.

COURSE GOALS

- 1.1 Listening comprehension: Students will continue to acquire basic aural skills.
- 1.2 Speaking: Students will continue to develop basic oral skills speaking in Spanish during guided conversations with other classmates.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 communicate in highly predictable everyday situations.
- 2.2 process and replicate oral information at novice level.
- 2.3 produce memorized material in simple statements or questions.
- 2.4 demonstrate understandable pronunciation skills when speaking.
- 2.5 recognize and explain everyday cultural patterns.
- 2.6 present and articulate personal information.
- 2.7 act appropriately in common everyday situations.

3. METHODS OF INSTRUCTION

- 3.1 Total Physical Response (TPR), along with the audio-lingual and natural approach
- 3.2 Discussions, readings, repetition of phrases, role playing of dialogues, and oral drills
- 3.3 Cultural multi-media
- 3.4 Any supplementary or unique method of instruction could be used by the instructor as long as the major objectives are met

4. LEARNING ACTIVIES

- 4.1 Group work in the classroom
- 4.2 Oral and listening quizzes and tests
- 4.3 Cultural multi-media
- 4.4 Classroom discussions
- 4.5 Commands executed in class

5. EVALUATION

- 5.1 A test after each chapter and a comprehensive final are required
- 5.2 Participation
- 5.3 Homework
