#### SPA 117 BEGINNING SPANISH FOR HEALTH CARE PROFESSIONALS

Credit Hours: 3 Lec 3

PREREQUISITE: None (Recommended SPA 115 or SPA 101)

## **COURSE DESCRIPTION**

This course covers basic Spanish language structure and vocabulary, appropriate phrasing, as well as specific acquisition of medical terminology, in a conversational setting.

- 1.2 Communicate orally in clear, coherent, and appropriate language

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 recite simple phrasing to obtain health history and assessment information.
- 2.2 employ simple phrasing to give patients information about their condition(s).
- 2.3 apply conversational Spanish phases for treatment and patient education.
- 2.4 use knowledge of basic cultural influences when talking to or treating patients.
- 2.5 use knowledge of basic cultural influences when communicating with family members.
- 2.6 integrate basic Spanish language grammar structures.
- 2.8 apply effective problem solving strategies in situations where appropriate vocabulary may not be available.
- analyze and interpret printed material.
