TEC 140 ROOFING SYSTEMS AND SAFETY

PREREQUISITE: None

COURSE DESCRIPTION

Focus is on the practical application and interpretation of appropriate safety and health standards relating to roofing systems, construction methods and materials for solar panel installation; this includes an introduction to established Occupational Safety and Health Standards.

1. <u>COURSE GOAL</u>

Student will be able to identify common roof systems and materials and explain and demonstrate the proper installation of solar photovoltaic panel mounting hardware to these structures. Student will be familiar with site safety practices and related fall-protection precautions to be followed.

Upon satisfactory completion of this course, students will be able to:

- 2.1 recognize common and hazardous situations on the job site and use precautionary methods to minimize risks.
- 2.2 identify, avoid and react to unsafe conditions associated with working at elevations.
- 2.3 select and properly use fall-protection equipment.
- 2.4 identify, set up and properly use various types of ladders and scaffolding.
- 2.5 identify materials used in residential and light commercial roofing.
- 2.6 use proper safety practices and application methods for various roofing materials.

6. <u>STUDENT RESPONSIBILITIES</u>
